- d. The Director can at any time, in the interest of the school, have a student removed for the following reasons
 - If the students does not accept the discipline of the school and if his/her presence is detrimental to the interest of other students.
 - 2. If the students fails to come up to the academic standard of his/her class and when detention in the same class would make the student too old for the class.
- e. No fees will be refunded if the student is required to leave school during the term for any reason other than that on medical grounds.
- f. Although the school will take all reasonable measures to ensure the safety of the children it will not be liable for any damages or changes on account of injuries, fatal or otherwise, which may be sustained by a child at any time during his/her stay in school, while taking part in studies, sports and extra curricular or any other form of activities of the school, within or outside the school premises. All expenses that may be incurred in the treatment of such injuries will be borne by the parents/guardians.
- g. Any dispute as to the effect or meaning of the above mentioned agreement will be referred to the sole arbitration of the Management Committee of International Public School, Meerut, whose decision will be final.
